2013 National Encampment Summary of Actions Taken

- New Rituals are now available
- Job Descriptions have been posted on the national website for everyone to review. Final acceptance will be voted on at the 2014 National Encampment.
- A committee to explore program ideas for Junior members created, as long as no expenses are incurred
- Guests may attend Auxiliary meetings, but are not to participate in discussions unless allowed by the Auxiliary. Guests may not vote at any time.
- Two Constitutional changes that must be ratified by each Department at their 2014 Department Encampments. Ratification forms will be sent to every Department President by the National Secretary. They must be voted on and returned to the National Secretary by July 31, 2014.
- Change acceptance of Constitutional changes from 2/3 Departments in Good Standing to 50%
- Allow legally adopted daughters to be members of the Auxiliary
- Delegate's Packets for National Encampments will be made available electronically
- National Per Capita Dues will be due once a year. They have also been raised to \$9.00 per Sister per year. Due dates: local Auxiliary Per Capita dues submitted to the Department Secretary by April 20.
 Department Per Capita Dues and Auxiliaries at Large submitted to the National Secretary by April 30.
- All Department Presidents and Secretaries will have an email address setup by the webmaster that will be linked to their private email address of choice
- The only contact information that will be posted on the National website will be for the National officers. All others will only have a telephone number and email address
- Biographies of Past National Presidents will be the one used for their Proceedings, unless they have submitted an updated one to the national webmaster, including photograph
- Photographs of interest from all Auxiliaries and Departments should be sent directly to the webmaster. They will be posted as room allows on the national website
- An official Facebook page will be created for publicity and information purposes only, and linked to the National website
- It is permissible to wear the Auxiliary Badge in public at proper functions and activities, as it is a way to introduce people to our Order
- All unpublished Minutes and Proceedings should be sent to a professional transcriptionist for immediate processing
- The Policy and Procedures committee is now a Standing Committee
- Balance of funds as of July 31, 2013: Checking \$15,962.75; Savings \$49,546.13; Total \$65,508.88
- The Girl Scout Committee will continue for another year, to assess the work done this past year, to see what, if any, changes may need to be made
- Four new Auxiliary Charters were presented
- An Auxiliary is nearly finished organizing in AZ
- Brother Richard Orr, PCinC and National Treasurer for the SUVCW graciously reported on their efforts in changing from a 501(C)4 to a 501(C)3. Each Auxiliary present was requested to take this extremely important information home and discuss thoroughly
- The National Patriotic Instructor Sister Allison Graff presented her donation to Civil Air Patrol 1st Lt Greg Turdo, WI. The Civil Air Patrol is the Auxiliary to the Air Force, teaching life skills to youth



NEW IRS REQUIREMENT - FORM 8822-B (effective January 1, 2014)

APPLIES TO: Auxiliaries and Department

If there is a change in the person who is the responsible person for filing IRS 990N or other IRS matters (normally the Auxiliary or Department Secretary, Treasurer, or Secretary/Treasurer), the Auxiliary or Department needs to submit an IRS Form 8822-B to report the change to the IRS. Effective January 1, 2014, the form must be filed within 60 days of the change.

If the responsible person is not sure a change was filed when they took over from the previous responsible person, it would be a good idea to file the form, anyway, to make sure the information is correct.

The updated Form 8822-B is available on the www.IRS.gov website. This form can be filled in online and printed out. The form must be mailed to the IRS at the address indicated for your state. Instructions are contained on page 2 of the form.

BE SURE AND CHECK THE BOX FOR TAX-EXEMPT ORGANIZATIONS at the top of the form.

Since we are trying to stay up-to-date with the IRS, I am here be issuing General Order #5.

That all Auxiliaries and Departments file an 8822-B within 60 days. That this form be distributed in the following manner:


