#### **ARTICLE IX**

#### **Amendments**

All proposed amendments to this constitution shall be submitted in writing to the National President, upon prior approval by some Department, not later than forty (40) days preceding **the meeting of** the National Encampment of the Auxiliary to Sons of Union Veterans of the Civil War, and such proposed amendments shall be published in **General Special** Orders preceding such **meetings meeting**. Such proposed amendments shall be adopted by a two-thirds (2/3) vote of the members present and entitled to vote at a stated meeting of the National **Encampment of the** Auxiliary to Sons of Union Veterans **of the Civil War**, and shall be effective when favorably acted upon and ratified by not less than **ten (10) 50% of the** Departments **in Good Standing**, and proclaimed in **General Special**

### From the Department of New York

#### WHEREAS:

Recently a letter was distributed to all National Officers and Past National Presidents concerning the application for a 501 C (3). The officers and the PNP's receiving the letter were asked not to discuss this letter within their respective Departments. A number of recipients of this letter feel that the subject matter is something that concerns the entire membership and therefore should be brought on the floor to the entire membership. Due to the enormous expense involved in obtaining and maintaining a501C(3). Therefore we recommend the following:

\*#1: We recommend that we suspend the current pursuit to obtain the 501C(3) status with the IRS at this time until there can be more research and documentations that we are eligible to apply and that questions or confusion about said application will be addressed to the satisfaction of the membership. WHEREAS:

This letter also stated that there was a possibility of the National Auxiliary being fined by the IRS due to the fact a National Officer was refusing to comply with certain requests from the National President. Let's get back to basic on what this organization stands for. We need to remember our aim is to perpetuate the memory of the "Boys in Blue" and at all times to do what is for the good of the order and not what is good for selected individual members. This is an organization governed by the membership. We elect officers to guide us and see that we run this organization the way the GAR and the founding members meant it to be run. Not try and impose our individual ideas-and wishes on the membership as a whole by going behind their back to accomplish what a select group of members deem is good for the order. Anything of that magnitude should be decided by the membership as a whole not having it done behind our backs.

Therefore we recommend the following:

#2: We recommend more focus be put on the original principles of Fraternity, Charity and Loyalty that this organization stands for and stop the inner turmoil that is threatening to destroy the organization from within, and redirect our focus on obtaining more members and supporting each other as "Sisters".

Prime Minister Winston Churchill made the statement "Power tends to corrupt; absolute power corrupts absolutely" Lets make sure we don't go there.

### From the Department of California and Pacific

#### Proposed Amendment to ARTICLE IV, Eligibility to Membership

Membership shall consist of:

**FIRST**, wives, sisters, daughters, legally adopted daughters, granddaughters, great-granddaughters and so forth, nieces and great-nieces and so forth, not less than twelve (12) years of age, of the deceased or honorably discharged Soldiers, Sailors or Marines who served in the Union Army, Navy or Coast Guard (including Revenue Cutter Service) during the Civil War of 1861 to 1865:

SECOND, legally adopted daughters of members with lineal or collateral descent from a Union Veteran of the Civil War;

SECOND THIRD, wives, mothers and legally adopted daughters of eligible Sons of Union Veterans in good standing;

**THIRD FOURTH**, any widow, mother or legally adopted daughter of an eligible Sons of Union Veterans who was in good standing at the time of his death;

**FOURTH FIFTH,** Departments and Auxiliaries may establish Associates, provided that the number of Associates in any Auxiliary shall not exceed one-third (1/3) of the total membership of the Auxiliary at the time of election. At no time during the meeting of an Auxiliary, a Department, or the National Organization can business be transacted if the number of Associates in attendance exceeds forty-nine percent (49%) of the total attendance then present at said meeting. Said Associates shall not be eligible to hold the office of National President, National Vice President, **National Secretary or National Treasurer** due to the lack of lineal or collateral descent from a Union Veteran of the Civil War.

All applicants must be American or naturalized citizens of the United States before being accepted in the Auxiliary.

### From the Department of Ohio

TO THE OFFICERS AND MEMBERS ATTENDING THE 127th NATIONAL ENCAMPMENT OF THE AUXILIARY TO SONS OF UNION VETERANS OF THE CIVIL WAR, GREETINGS:

At the 127th Ohio Department Encampment held in Columbus, Ohio on June 8th, 2013, the Delegates assembled passed the following recommendations: Recommendation #1:

WHEREAS, it is an easy and free method of advertising;

THEREFORE, we incorporate in writing that we be allowed to wear our membership badges in public. Recommendation #2:

WHEREAS, the ASUVCW is not a 501(c)(3) non-profit organization, as of this date, and therefore, our fundraising opportunities are greatly hindered because of the lack of this tax deduction status to donors and our own subjectivity to tax liability; and, WHEREAS, the ASUVCW's financial accounts, are not updated, nor have they been audited or reviewed, thereby making it so that the ASUVCW, amongst other detriments, cannot apply for this status; and, WHEREAS, most importantly, the Sons of Union Veterans of the Civil War, our

parent organization, can no longer be expected to support the ASUVCW because of the lack of a 501(c)(3);

THEREFORE, the Eliza Garfield Auxiliary # 142 recommends that the Department of Ohio thus send a recommendation to the National Office of the ASUVCW that acquiring a 501(c)(3) become a priority for the National Organization and that their records be set straight so that this is able to be acquired in an expeditious period of
