Report of National President.

ANNUAL REPORT OF THE NATIONAL PRESIDENT.

SIDNEY, OHIO, September 5th, 1889.

Officers and Members of the Third National Encampment, Ladies' Aid Societies, Sons of Veterans, U. S. A.

DEAR SISTERS:—I am sure you will rejoice with me in the present substantial prosperity of our beloved Order. You are all individually deserving of the happy privilege of being proud because we are closing the second year of the existence of this National Encampment with a most fruitful harvest as a reward of our labors.

The numerical strength of the Order, together with all the details of organization will be found in the report of the National Secretary. Treasurer will give the financial transactions of the past year and the present condition of this Encampment. The National Council's report will treat upon some important matters that I might have presented to you, but which I thought best to refer to them. I am convinced that the reports of these officers should embrace all that comes within the provinces of their For this reason it will be necessary to take the full reports as a whole to know all about the facts and figures of my administration for the I will only say in this connection that I have paid every cent of the indebtedness reported to previous Encampments by Miss Laura F. Martin and myself. There is a large quantity of good salable supplies on hand, which with the cash makes us worth about one thousand dollars. you to feel that you gained this victory. I assure you I cannot believe that our success came from the endeavors of any one part of our organization, Your aid was necesbut is the result of the struggles of the entire Order. sary and I believe you are so fully aware of this, that this meeting will increase our knowledge of the needs of the Order and strengthen our zeal to carry them out, and that the renewal of our personal and social associations We can do more will give us more strength for the year's work before us. in the coming year than we have done in the past. If we develop now all our past experiences we can build a substantial and enduring foundation on which it will be easy to erect an everliving monument of our desires to show that we revere our fathers' and mothers' devotion to their government by perpetuating the pure and holy spirit of their loyalty. We did not accom-We have failed in some things that sorely plish everything we tried to do. grieves us, but it was so with our patriotic fathers and they were stronger than we are while their sterner nature and disposition upheld them where ours could not. Even with these depressing facts before us we can be bright and joyful over our success.

The internal relations of our entire Order has been very pleasant and There was but one case of dissatisfaction or trouble that was harmonious. not adjusted before being carried to me for settlement. I am most happy in recording this fact, for I think if arguments are ever necessary to prove the absolute need of an Order of our character we have only to show our record for wholesome love of our Sisters and our Order and the absence of all quarrels and disturbances. I pray that it will always be so. been called upon to approve a single case of dishonorable dismissal from the Order and no appeal has ever been made by a Sister or Society claiming an injustice done them with the exception noted. The Sons of Veterans, United States of America have continued to give us a full share of their endorsement and approval. We have suffered with us a full snare of their charges but have shared in the revival of their the loss of interest in their carries are linear regions. enthusiasm or the outbursts of their earnest zeal in carrying out the purpo. enthusiasm of the outburders they have gained the approval of that noble body of patriots, the Grand Army of the Republic, they will be free from the restraint that has so long held them in check, and we may hope to enjoy an The competition between rival increased interest in our Order from them. Orders has been a source of discontent for some years for our Brothers and we can rejoice with them in the prospect of its removal. We may not perhaps be able to fully appreciate this victory of our Brothers, as we have no competitors. There are many kindred Orders working similarly and having virtually the same objects, but they are auxiliaries to the Grand Army of the Republic. According to their constitution and declaration of objects they cannot assume to take our place, and we should not call them rivals. Many Sisters thought the organization called the Daughters of Veterans would encroach upon us; but such is not the case. It is true their principles are copied bodily from our Constitution without changing a single word or the arrangement, but they define their objects to aid the Grand Army of the Republic wholly, and no mention whatever is made of the Sons of Veterans. The position they take would thus make them more properly a rival of our Brothers than ourselves. We should be happy that we are free from anxiety on this account to hasten to assure the Sons of Veterans, U. S. A., that they have our sympathy and support in all they undertake.

#### ORGANIZATION.

The work of organization of new Societies has been ably done by the Presidents of the chartered Divisions of Pennsylvania, Ohio, Illinois and Iowa and by our Brothers and Sisters in all other States. You will be gratified with a perusal of the National Secretary's report. I am indebted for this valuable work to Mrs. Ada L. Shannon and Mr. C. F. Rank, of Pennsylvania; Mrs. Emma E. Deeds and Mrs. J. S. Mason, of Ohio; Mrs. J. Q. Annable and Mrs. F. B. Funk, of Illinois, and Mrs. Lou K. Moore, of Iowa. for the great gains made in their Divisions. I would be pleased to mention individually the many Sisters and Brothers who have done so much towards bringing our Order its present success, they all deserve special mention. hope they will feel that I appreciate their work, although I have not included their names in the list given. I am thankful to all of them, and hope the satisfaction of having aided my labors will bring them gladness, and that prosperity will never forsake them or theirs. While we have met with some reverses they were almost wholly due to the fact that we were women and for this reason our labors and efforts are not so positively apparent as in the work of our fathers or brothers. This we should not complain of, for as an auxiliary of the Sons of Veterans we must expect to have our actions limited to a certain extent by their wishes. I believe in main-

taining our independence as an organization, but we must consult their views in our work. This may hamper our movements slightly and partly check our eagerness to prove that we have as earnest, unselfish and willing a spirit as our fathers and brothers. I am frank in saying that we have not grown impatient because we were not free at all times to soar as we would like, or may not have received the flattering attention that we expected. would not speak in this strain were it not that some of our Societies have become discouraged because their efforts were so little noticed and praises were so coldly bestowed, that it somewhat chilled their ardor. While it is our nature to seek the approbation and commendation of those for whom our Order was organized as a helpmate, we should not imagine that we are being neglected, and that no thought whatever is given us by the world around us. Our fathers and brothers are watching our movements closely, and if we only have the determination to keep our little bands firmly united and do not yield to the thought that our efforts are unappreciated they will at no distant day be so proud of our work that they will overwhelm us with their plaudits. Our good Brothers have so much to contend with themselves in perfecting the pathway of their Order, and gaining the recognition that they deserve from every citizen of our glorious government, that they cannot at all times devote us as much praise and attention perhaps as we are entitled to. We should not allow this to interfere with our ambition to grow, and above all, we should not refuse to do our whole duty, as we are pledged, for our fathers suffered many a defeat upon southern battle fields before they conquered. I can realize why so many of our Societies have gone down in their struggle to assume all the financial and business responsibilities necessary in providing meeting halls and paying I am pained beyond expression to say that these two monetary obstacles have crushed out the life of several of our Societies the past It is discouraging to know that we are restricted in our means of obtaining the money necessary to meet the legitimate expenses of conducting the business of the Societies and Order.

I will make no recommendations to you or try to outline the work of the Encampment as it should be done. This you are competent to do yourselves, and I have no wish to influence legislation in any way. I appointed a Committee some weeks ago on Ritual and Burial Ceremonies who will report to you their conclusions, and I think you realize the necessity of perfecting these parts of our services. The other routine of work to be done here is so clearly in view that you can see at a glance what is to be done, and I know you will not hesitate to do it.

I wish before closing to explain the only delay in the work of my office that has caused any dissatisfaction. This was the failure to have the Constitution, Rules and Regulations adopted at Wheeling printed early enough for shipment to meet the demands for the revised work. The chairman of the committee volunteered to do the arduous work of preparing it for the printer. This took so much time that it was close to the

end of 1888 before they were ready. After my printer had them about completed a fire occurred in the bindery and destroyed them. We suffered no loss in this except by delay. They had to be reprinted, and, hence, I could not do else but disappoint many Societies on this account. I hope this explanation will suffice, and that no blame will be attached to anyone as it was impossible to avoid the delay. The thanks of the Order is most assuredly due to Nevins & Co., of Cleveland, Ohio, who have done all the printing since I assumed the office in 1887. They have trusted us for several hundred dollars worth of supplies, and have been most patient in waiting for me to gather a sufficient amount to pay them. I hope the Order will appreciate this great favor.

I beg you to give my successor the same earnest, unselfish assistance you have given me. She cannot do the immense amount of work that will be required of her if you do not. I heartily thank you all for your kindness to me and my officers. It will always be the most pleasant recollection of my life. I feel only the deepest regard for each of you and am happy to hear from your lips the expressions of good feeling you bear to all my acts.

To my officers who have been such faithful adherents and to every Sister of the Order and every Brother Son of a Veteran I pray God to bless you all and that His guiding hand will crown our Order with His immortal and everlasting blessing, and that our Brothers and Fathers and all the world will feel that our work has not been in vain.

#### SECRETARY'S REPORT.

SIDNEY, OHIO, September 5, 1889.

Mrs. W. D. A. O'Brien, National President Ladies' Aid Societies, Sons of Veterans, United States of America:

DEAR SISTER: I am pleased to present you my annual report. The increase in the number of new Societies will be very marked. There has been a slight decrease in the number of Societies by voluntary surrender of charters, a few have had their charters revoked, while a number have been suspended for failure to pay the per capita tax. Many reasons have been given for this failure to comply with the rules and regulations and keep themselves in good standing, the principle one being the expense of hall rents and janitor fees. In almost all cases these expenses were, in reality, much greater than necessary, judging with my knowledge of the cases. With our Order granting the privilege of meeting in the residences of members while the Society is small and poor, it is strange that many will incur the heavy expense for a hall to meet in.

We have issued five general orders. A copy of each accompanies this report.

Thinking it would be best, or more satisfactory, to give the details of organization of new Societies and loss of old ones, by states, I have arranged it so.
