# Ethel V. Carver, PNP National Auxiliary 1921-1994

Sister Ethel Carver joined Appomattox Auxiliary #2 of Wilmington, DE, February 6, 1939. She was the great granddaughter of Pvt. Samuel Suthel of the 1st Delaware Infantry, Company F.

She held many offices in her Auxiliary as well as the Maryland-Delaware Department. She was Department President three different years and was sitting Department President at the time of her death. She always worked for the good of the Order and when a Chief of Staff was needed, she always would volunteer.

She also held the National offices of Chief of Staff, Press Correspondent and Council Member.

The highlight of her life was when she was elected National President in Indianapolis, Indiana, in 1991. Her National Encampment was held in Pittsburgh, PA in August of 1992. I do not know of anyone who enjoyed her year more than she did. She traveled many places that year, including California. If she didn't visit, it was conflicting dates that prevented her from being there.

Sister Carver was terminally ill at her Encampment. The doctor wanted to put her in the hospital at that time but she told him she would not give up her Encampment. She insisted on attending the National in Portland, Maine, even though her life span was short.

Sister Carver loved our organization and I do not know of anyone who did more in her condition. Our National Officers put on the Memorial Service at her viewing. This would have made her very happy.

She was a member of the Eastlake United Methodist Church, and was a trustee, past secretary of Brandywine Summit Camp, a member of the Wilmington Memorial Day Parade for many years, and worked for the mentally retarded of Delaware.

She is survived by a son, Robert Carver, a granddaughter, Tiffany, and her cousin, Dorothy L. Hilyard, PNP, with whom she was raised.

The Campfire was well attended; the guests enjoyed Civil War period music by the 7th Michigan Volunteer Infantry Fife and Drum Corps. The highlight was the talk about Michigan in the War by Chief Historian of the National Park Service in Washington, DC, Edwin Bearrs, who gave an extremely enthusiastic speech (with no notes). He was also featured as a commentator on the Ken Burn's series, "The Civil War", on PBS. On view for the first time was one of few known surviving Custer Badges. The badge commissioned by Gen. On display were SUVCW/Civil War artifacts including Michigan Civil War veterans, photographs of the flag project they were instrumental in raising funds to help restore, and cemetery restoration process.

# REPORT OF THE NATIONAL PRESIDENT

Lansing, Michigan

August 11, 1994

To The Officers and Members of the 108th National Encampment of the Auxiliary to the Sons of the Union Veterans of the Civil War, Greetings.

When I was elected as National President one year ago, I knew that I was committing myself to a busy year with much to be done. It is somewhat difficult to definitely describe this past year, but it has truly been an experience. There have been challenges, disappointments, and unexpected surprises, there have been so many rewarding experiences, excitement and good times that it has been a year I will never forget. It was the wonderful support and encouragement of everyone in our beloved Order that helped to make this such an unforgettable year.

#### IN MEMORIAM

It is with great sadness that I report that our golden chain of Past National Presidents was once again broken with the death last January of Past National President Ethel Carver of the Maryland/Delaware Department. Two years ago, I served as Sister Ethel's National Chief of Staff. During that year, I got to know Sister Ethel quite well and we became even closer friends than before. Ethel was a very loyal and dedicated member of our Order and loved it dearly. She was always willing to help out whenever called upon. Even near the end, she still wanted to attend Organization affairs and was very disappointed when her health did not permit it. She will be missed by all.

#### **FINANCES**

The Chief of Staff and Patriotic Instructor have both worked very hard this past year to raise funds for our Organization. I have tried to assist these Sisters in their efforts by selling chance books, raffle tickets and quilt pieces in my travels around the country. These officers have spent a lot of time thinking of ways to raise money in addition to donations and raffles and both the National Director of the Budget and I sincerely appreciate the support of these Sisters.

I would like to offer

RECOMMENDATION #1: That the Per Capita Tax of 35 cents per member per quarter remain the same for the coming year.

I am very happy to report that relations with the Sons have been most harmonious this past year. Commander-in-Chief Allen W. Moore has been very cordial and cooperative. He stated to me that since Indiana no longer has a Department Auxiliary, only a Provisional one, he was not too familiar with the workings of the Auxiliary and would be glad to have input from us and was always willing to listen to any suggestions we might have on how to make things run more smoothly for both Organizations. Between Bud Atkinson and Allen Moore, I feel that the strained relationships of the past few years are well on their way to being healed.

I, therefore, would like to offer

RECOMMENDATION #2: That a "Love Token" of \$250.00 once again be given to the National Organization of the Sons of Union Veterans of the Civil War here assembled.

As Commander-in-Chief Allen Moore has been such a pleasure to serve with this past year, it gives me a great pleasure to offer

RECOMMENDATION #3: That we give with our best wishes our usual "Love Token" of \$60.00 to Commander-in-Chief Allen Moore.

#### **ALLIED ORDERS**

This past year, I have had the pleasure of meeting with the other three National Heads on several occasions. All of these ladies, Phyllis Houston of the Ladies of the Grand Army of the Republic, Dorothy Coluntano of the Daughters of the Union Veterans, and Elsie Gould of the National Woman's Relief Corps, are most congenial and it was a pleasure to spend time with all of them. I first met Dorothy Coluntano of the Daughters last September in Richmond at the rededication of the Libby Prison site. All five of us attended the Remembrance Day ceremonies in Gettysburg. Phyllis Houston of the Ladies, I have known for several years though not on a personal basis, and Elsie Gould of the National Woman's Relief Corps, I have met for the first time. She, too, is a very gracious lady. We all had a chance to get together after the banquet and get better acquainted. We were all together once again in Springfield for the Lincoln Death Day ceremonies, and once again had the opportunity to get together. I am very pleased to say that we have all been keeping in touch.

#### SCHOLARSHIP AWARD

The National Scholarship Award was given this year to Sister Denise Spring. As Denise is my daughter-in-law, I gave a lot of serious thought to the matter and read through many requests before I made my final decision. Denise was a working mother trying to pursue her life-long dream of being a nurse. She knew that sacrifices would have to be made in order to attain this goal but felt that it was worthwhile. The scholarship award helped her to purchase uniforms and more textbooks and visual aids that were needed for the completion of her schooling. I am very proud to say that Denise has maintained a 3.8 average and will graduate with a degree in nursing later this month. She is now a life member of the Auxiliary #2 and, in spite of her hectic schedule, managed to serve as our Department Chaplain last year.

Having received so many requests for the scholarship, I have found out how important the extra financial aid is to most students and I, therefore, offer

RECOMMENDATION #4: That the \$350.00 scholarship continue to be given and that the recipient continue to be the personal choice of the National President.

At the Encampment last year, a recommendation was made and passed that the scholarship be listed in the first General Order stating how and where to apply and what the qualifications are. This was done. However, after reading over the many requests I received, I noticed that most of the requests came from students who stated that they would like to attend college. As most of these requests came from students who are not yet attending college and we have no way of knowing if they will be able to pass the entrance exam or will be accepted at a college or will possibly change their minds, this could possibly result in the award money not being used for the purpose for which it was intended, to further an education. I, therefore, offer

RECOMMENDATION #5: That the scholarship award be given to a student already attending college or who has been accepted at a college.

#### BANNER

The issues of the BANNER have greatly improved under the BANNER Editor, Russell Gregory. There are a lot more items of interest and I am pleased to once again be reading so much about the Auxiliary activities. Please keep sending your news items to the BANNER.

#### GENERAL ORDERS AND CORRESPONDENCE

Three General Orders were issued this past year. I have tried to keep everyone informed of all events occurring as well as illnesses and deaths. Thanks to our National Secretary for keeping me up-to-date on some of these things so I could include them in my Orders. Correspondence has been monumental and I have tried to be as prompt as possible with my replies; however, with my traveling schedule it has not always been possible to be as prompt as I would like to have been and I still have some correspondence to complete when I return home.

#### WREATH PRESENTATIONS

The laying of wreaths for the Auxiliary is always a most pleasurable task.

On November 19th, I placed a wreath at the Albert Woolson monument in Gettysburg commemorating the 37th GAR Remembrance Day services.

I was extremely disappointed that I was not able to present the wreath at the Lincoln Memorial in Washington, D.C. on February 12th. This was because of an eighteen-inch snow storm we received on February 11th. After consulting with the National Counselor, who advised me not to attempt the trip, I received a call from Margaret Atkinson who stated that she and Bud had been advised by those in the area not to attend because of weather conditions, so I decided not to attend. Even though I was disappointed, I was later relieved that I did not go as a severe ice storm followed the snow. I would like to sincerely thank Past Commander-in-Chief Charles Corfman for laying the wreath for me.

I was so pleased to present the wreath at Lincoln's Tomb in Springfield on April 15th at the Death Day Ceremonies. Springfield was so exciting and since I had not been there since I was a child, I played the role of a tourist and did as much sightseeing as possible. I was absolutely fascinated. I had brought the National Organization's flag with me and the Honor Guard was very pleased that I did as the Commander-in-Chief and I were the only ones who had brought Organization flags. My son carried the Auxiliary's flag and marched with the Honor Guard. I was so happy to get the chance to see Past National President Ellinore Johnson while I was there. She extended every courtesy to me and made my stay very pleasant. She expressed to me how pleased and honored she was when the Auxiliary named her Chairman Emeritus of the Legislative Committee. She looked great and asked me to say hello to everyone for her. While in Springfield, I got the opportunity to visit the National Headquarters of the Daughters and was greeted by N. P. Dorothy Coluntano who gave me a tour of their building. The Daughters were quite busy trying to clean up the damages done by a recent storm and were attempting to get the work done before Death Day. Before I left the building, I was presented with an old Auxiliary badge by one of the Daughters. I also got a chance to visit the GAR building. Even though the building had closed for the day, when I attempted to visit it the previous day. I was informed that someone is usually still there after closing, and all I would have had to do was to knock on the door and identify myself and they would have admitted me. I was also given a tour of their building and was very impressed with all the history and artifacts that they have managed to gather and preserve.

I was unable to attend the wreath laying ceremonies at the Cathedral of the Pines in New Hampshire. The ceremonies were held on May 29th, the day before Memorial Day and, as I was committed to represent the Organization with local veterans groups, I would not have been able to be back on time. I had been looking forward to going to the Cathedral of the Pines as I had never been there and had heard so much about it. I would have loved to have been able to see it for myself. Special thanks to Past National President Catherine Zapatka for representing me.

#### PROVISIONAL AUXILIARIES

I am very pleased to say that the Provisional Auxiliary in Columbus, Ohio was instituted by Past National President Bea Greenwalt and is doing well. I regret that I could not attend since I had already started my visitations and was away at that time.

Unfortunately, the Provisional Auxiliary that was to be instituted in Dublin, California, still has not been instituted. Plans had been made for me to institute this Auxiliary when I made my official visit to the California/Pacific Encampment last March. When the ladies arrived, there were six in all. Since the Charter contained seven names, I inquired if the seventh person listed would be coming. I was told that two of the persons listed were not able to attend. I then asked the Department Secretary to supply me with the applications of those listed on the Charter and, after checking them, I found that one of those listed on the Charter did not have eligibility and could only be an associate. The sixth woman in attendance stated that her husband had eligibility but was not a member of the Sons. This left only four eligible members and since it requires five members to issue a Provisional Charter, the Auxiliary could not be instituted. Since these women traveled quite a distance, I told them that they could become members of the San Jose Auxiliary and when they attained the necessary eligible members, they could receive a discharge from the San Jose Auxiliary and institute a Provisional Auxiliary in their area. They consented to this and were initiated into the San Jose Auxiliary by Past National President Betty Woerner, along with another woman whose husband was attending the Sons Encampment, and who will remain a member of the San Jose Auxiliary. After several attempts at instituting this Auxiliary which have failed due to not being able to reach a mutually convenient date because of other commitments, vacations, and so forth, they are all trying to work out a mutual date to get this Auxiliary instituted. Hopefully, it will be in the very near future. Six of the women initiated that day are members of a reenactment group with over 1200 members, and I feel that this is a good opportunity for us to gain many new members for the Organization as well as new members for the Sons.

The Institutor of New Auxiliaries, Isabelle Roberts, was supplied with the names of twenty-nine women wishing to form a new Auxiliary in Massachusetts. She has personally contacted all of these women by mail and most of them by phone to ascertain their interest. She has informed me that things look promising.

Since the work of the New Auxiliary Institutor is in the best interest of the Organization, I therefore, offer

RECOMMENDATION #6: That the New Auxiliary Institutor be given some monetary amount to help defray the cost of postage, phone calls and expenses incurred in carrying out her duties. This amount to be set by the National Organization.

In addition, due to the many problems encountered in instituting the new Auxiliary in California, I offer

RECOMMENDATION #7: That the Charter for Provisional Auxiliaries not be issued until the day the Auxiliary is instituted so that all names to appear on the Charter can be verified as being those of eligible members.

This is a procedure followed by the Sons and seems to be successful for them.

On my visitations to the various Departments, I tried to rally support for the Department of Rhode Island by encouraging other Departments to write letters to their representatives denouncing the treatment experienced by the Rhode Island Department in their efforts to regain the GAR property that rightfully belongs to them.

At the New Jersey Department Encampment, I was very proud to see my son, Patrick, presented with the Department Sons Good Citizenship Award for outstanding service to the community.

Last year, after my installation, I was asked by the Organization to make a trip to Illinois to try to solve the problems they were experiencing in their Department. As you will recall, the Department President, Vice President, and Treasurer had all resigned from their offices and wanted to surrender the Department Charter and properties. A letter from Past National President Florence Forbey to the National Organization asked the Organization to intervene and try to help resolve the problems. She stated that if this could not be done, she asked permission for the Department Charter to be sent to her Auxiliary for safekeeping. The CR&R specifically states that if ten members desire to continue on as members, the Department Charter cannot be surrendered. It also states that when a Department Charter is surrendered, it must be returned to National. Shortly after my return from National last year, I started sending letters to the Illinois Department Secretary, whose name had been given to me as the person to contact and offering to assist in any way possible to help resolve their Department problems. These letters were also followed up with letters from National Secretary Margaret Atkinson.

During the entire year, neither Margaret nor I ever received even the courtesy of a reply. I had even written when I was planning on being in Springfield, Illinois hoping that possibly there would be some way that I could meet with someone from the Department while I was in Illinois. I was willing to travel anywhere in Illinois that might be convenient for them but as usual, no reply. Then in early June, I received a phone call from Florence Forbey informing me that she had found some members who were willing to fill the Department offices and would I give permission for the Department to hold an election. She also asked that since she had recently been discharged from the hospital and would be unable to install the officers herself, would it be permissible for a Past Department President to install the new officers. I told her as long as the Per Capita Tax for the Department was up to date, both of these things could be done. When I explained to her all the problems Margaret and I had encountered with the Department Secretary not responding to our letters, she said that under the circumstances that perhaps the Department should also consider replacing the Secretary. The reason she was asking permission for the elections to be held was because she felt that by the time all arrangements were finalized, the election would be held after the June 30th deadline for Department installations. She was then in contact with the National Secretary who informed her that the Department Per Capita Tax had not been paid since last September. She stated that she personally would pay the Per Capita Taxes and seek reimbursement later from the Department. The last I have heard is that things are moving along and, hopefully, before long all problems will have been settled.

EILEEN COOMBS, PNP, ME: I second the motion.

PRESIDENT FLORENCE: A motion has been made by PNP Florence Jansson and seconded by PNP Eileen Coombs, that all officers' reports be received, spread full in the minutes and the reports turned over to the Committee on Officers Reports. The Guide and Assistant Guide will collect the reports as they are read and see that they are turned over to the Chairman. May we have the National Council report at this time.

#### REPORT OF NATIONAL COUNCIL

We, the members of the National Council, have audited the books of the Secretary and Treasurer and found them correct. We thank them for all their hard work in their prospective offices.

National Treasurer Eileen Coombs asked the opinion of the Council one time last year with respect to funds in Iowa and members answered her immediately.

National Council #1 Frances Murray told of old badges received from a Maine Auxiliary and of old badges in the Iowa Department from the Waterloo Auxiliary. These badges cannot be sold. It was moved and seconded that if an Auxiliary does not want their old badges, they should be turned over to the Department. If the Department does not want them, they should be turned over to National. A suggestion was made that we might use an old badge as an award for a member of the Auxiliary or Sons. So Voted.

The new historical brochure was shown and they will be given out at no charge. However, it was Moved and Seconded that a Department and/or Auxiliary pay the postage for the mailing of the new historical brochure. The incoming National President will put this in her first General Orders.

National Treasurer Eileen Coombs told of a check for \$6.00 in April 1993 for Life Membership dues that has not been received by an Auxiliary. Moved, Seconded and So Voted that this \$6.00 be replaced by the National Treasurer.

A discussion was held on the loss of membership and difficulty in forming new Auxiliaries when members cannot be present. It was discussed that the Obligation be added to the Application Form, like Membership At Large, and when an applicant signs her application and returns it to the Auxiliary, when it is approved by the Investigating Committee, the applicant would immediately become a member. Ritualistic Initiation would follow at a later date.

Sister Florence, we have enjoyed working with you this year and wish for you a gratifying convention.

PRESIDENT FLORENCE: Thank you very much for your fine report. Now for the Report of the National Secretary Margaret Atkinson.

#### REPORT OF NATIONAL SECRETARY

It hardly seems possible that I have filled the office of National Secretary for two years already. When Ethel Carver first approached me with the request that I fill the office while Frances Murray served as National President and Council, she told me I might even grow to like the job. Well, she was right, I have enjoyed serving the Auxiliary in this position. It does entail a large volume of work, but being able to keep in personal touch with the membership more than compensates for this. I have thoroughly enjoyed receiving your notes and letters and hope the National body was satisfied with my performance of the duties of this office.

During the past year, I had printed and mailed three General Orders; seven newsletters to the National officers and Past Nationals; proofed, had printed and distributed the 1993 Proceedings; answered correspondence; typed and mailed copies of the changes to the CR&R to officers, both National and Department. I have brought additional copies of the CR&R changes with me, if anyone should desire a copy.

I was appointed to the committee to create an informational brochure about the Auxiliary. The Chair, PNP Frances Murray, will deliver the report of this committee; however, I have brought a supply with me and urge the membership to take some home and use them. I understand that a new membership application is also being designed.

One of the duties of the secretary is to keep an accurate list of the membership throughout the National Organization. This has proved extremely difficult in the past, as the names of deceased or dropped members are not always listed on the back of the Per Capita Forms by the Department Secretaries. This is due, in part, to the information they receive from the local auxiliaries. In addition, addresses for new members are not always provided. Every five years, we must comply with Federal regulations and provide this information to the government, creating the need periodically to issue a special request to all the auxiliaries for the names of their members.

With the thought in mind that if the Per Capita Form were designed in such a way as to request full information, the secretaries will provide it, I have sent the following requests to the Chairperson of the Revision of Blanks Committee:

- 1. Per Capita Forms for Auxiliaries: Change the back of the form to require the name, address and auxiliary of each new member.
- 2. Per Capita Forms For Departments: As above, change the back of the form to require the name, address, and auxiliary of new members.

As previously, the names of deceased or discharged members should continue to be listed on the back, with a special notation if they are a Past Department President.

I sent a second request to the Revision of Blanks Committee that the Department Installation Report be revised. National needs the names and addresses of Department Council Members, however, the form does not provide a place for this information. My request is as follows:

"Delete the spaces provided for Inspector and I. & I. Officers as these offices are discontinued, and insert three spaces for Department Council."

I have given a great deal of thought this past year as to the best way for the National Secretary to keep an up-to-date and accurate list of members after she receives the information from the Department Secretary. If these names were put on a computer and udpated quarterly as the reports are received, we would always have a current list of the members available for the Director of the Budget or for any other needs. The initial setting up of this list would take a considerable amount of time. I had stated last year I was going to try to do this, but soon found it difficult to find the time to devote to this task. The Secretary already has a large volume of paperwork. If someone were appointed to do the initial set up of this program on a computer, it could then be handled one of two ways. Either this person would continue to update the list quarterly by obtaining the information from the National Secretary, or she would give the computer discs to the secretary to use in her own computer.

I feel it is important to our order to have a list of our membership, and therefore make the following recommendation:

"That a member of the organization be appointed as Membership List Coordinator (or some similar name) to set up a computer program on which we would list the names, addresses, and auxiliary of every member of our organization. She would then input all the information required to complete this listing. Subsequently, either this appointee, or the National Secretary, would continue to update the list quarterly."

If the national body approves this recommendation, I have obtained a volunteer who is very experienced in computers and is willing to undertake this task for the Order. I also sent a request to all Department secretaries in June to provide a list of their members by September 1st and have already received several replies.

A year and a half ago, I was appointed to assist a group of women in California to start an Auxiliary in the Dublin area. Our New Auxiliary Organizer Isabelle Roberts has also been involved. Because of the distance, it has proved a difficult task and has entailed a voluminous amount of correspondence. There have been several dates set for initiating this auxiliary, none of which transpired, but it is my fervent hope that it will be accomplished by the time of this meeting. It did bring to my attention that we need to study and clarify our procedures for starting a new auxiliary. Although a committee met last year, all the questions were not answered. We need new members desperately so we must find ways to initiate new auxiliaries quickly without compromising our standards.

One of the tasks of the secretary is to keep a count of the number of members in the Order. When one is not looking at these figures constantly, one is aware that we are growing smaller but probably do not realize to what extent. Two years ago we suffered a net loss of 43 members; this past year we suffered a net loss of 92 members; giving us a total current membership of 1111. It can be seen how our losses are escalating despite acquiring new members and forming several new auxiliaries. Many of us are long-time members who are extremely loyal to the Order and have given many years of service. At the same time, a considerable proportion of our membership are in the mature years of their life. If we are to preserve this Order we love so much, and not be phased out in another ten years, we must become aggressive in our recruitment of new members.

Recently, I began checking into the possibility of obtaining members through advertising. Several Civil War periodicals will run a 25-word ad free for three months if you have a subscription, while others charge varying rates. The brochures we had printed could be distributed nationwide and members place them in local libraries, visitor centers, etc. A short writeup could be composed and printed in the General Orders as a suggested article for members to send to local papers. The Senior Vice Commander-in-Chief of the Sons could be contacted and asked to supply us with information on new camps being formed. We could then write to them suggesting they also form an Auxiliary. If they expressed interest, this information would be passed along to the New Auxiliary Organizer. If any requests for membership were received and sent to Departments, these could be followed up to ensure the prospect had been contacted. I am certain there are more ways to recruit than I have mentioned.

In view of the above, I make the following recommendation:

"That a Publicity Committee be formed to work under the Chairmanship of the National Vice President. This committee would seek ways to gain free publicity for the Auxiliary, compose publicity notices as samples for members, encourage use of our brochures and use any other means to promote membership. They would also investigate costs of paid advertising and submit a report to the Director of the Budget and National Counsel for their consideration. I would further recommend that the postal costs incurred by the National Vice President and her committee by reimbursed by the Auxiliary."

If this resolution is accepted by the membership, I have advertising materials to turn over to them and have also secured several Sisters who have volunteered to work on this committee.

During the past year I have attended many functions of the Auxiliary on the local, state and national level. On the occasion of the death of Past National President Ethel Carver, it was my sad duty to assist with the Order's funeral service. I continued my duties to the GAR Museum as secretary and guide and was still able to visit some schools and community groups with Civil War talks and demonstrations. My heartfelt thanks are extended to our National Treasurer Eileen Coombs, for her cooperation and friendship during the past year. The National Auxiliary is most fortunate to have such a dedicated, conscientious worker in this very important office of treasurer.

To our National President Florence Spring, the past year has allowed me to become better acquainted with both you and your family. It was been an enjoyable experience to work with you and you have served the Order well. My congratulations and best wishes for continued health and happiness.

Please accept my apologies for the length of this report, but I felt compelled to speak on the issues as I saw them. Thank you for this opportunity to serve the Auxiliary. The statistical report of the number of members and Auxiliaries follows.

PRESIDENT FLORENCE: Thank you Sister Margaret for your dedication and detailed report. We all appreciate your hard work and keeping us up to date. Now may we have the Report of National Treasurer Eileen Coombs?

#### REPORT OF THE NATIONAL TREASURER

Having completed my first year in this office, I sincerely hope I have fulfilled it in a way as not to be a disappointment to those who had enough confidence in me to appoint me to this office.

It has been a learning experience for me, but I have enjoyed it all. I have tried to fill all orders for supplies as rapidly as possible and only hope the few delays was not an inconvenience for anyone. I have endeavored to answer all correspondence as soon as possible.

Esther Peiper sent me \$1500 to establish a checking account and when all checks were in and she could close the account in Ohio, she sent me the balance as well as the Savings Account Funds. I think the transition went well. Thanks to Esther Peiper.

I was able to get a checking account with no service charge, no interest, and unlimited checks. Our first book of checks cost \$33.45 for 300 checks. Our savings account is a business savings account for non-profit organization. Interest will vary depending on the amount in the account. Minimum of \$1000, no service charge if we keep the minimum in the account. To date, we have had no service charges.

One of the most time consuming jobs that was a bit worrisome to me, was getting the C.D. of \$9500 from the bank in Iowa; their rate was the same as one of the Rhode Island banks. The C.D. matured on March 14, 1994. I sent a letter to the National President, 3 Council Members, the Director of Budget and the National Secretary regarding to move the C.D. to Rhode Island and to put it back to the two original C.D.s: \$7500 for Patriotic Instructor Fund; \$2000 for the Permanent Fund. Our savings account was up to \$11244.38 and after conferring with these officers, I withdrew \$5000 from the savings account to make the \$7000 Permanent Fund C.D. These two C.D.s are for one year because I could not get a better rate unless I got them for 5 years. This is much too long a time as the market could change. We do gain more interest on a C.D. than in a savings account. By authorization of the National President, I rolled over the C.D. in the Dauphin Bank in Pennsylvania for another year. I want to thank these officers for their fine cooperation when I needed it most.

We have made every effort to keep within the budget this year; however, our Per Capita income is below the estimate and interest rates are down in all banks, and postage is expected to go up. I have filled 41 orders for supplies. Some of these orders I was able to deliver in person and this saved a little postage. The first thing I had to do was make up supply packets for the new auxiliaries in California, Maine, New York and Rhode Island. Esther gave Beatrice Greenwalt a partial supply package at the end of last Encampment for the new auxiliary in Ohio; Beatrice and I corresponded and I sent the remaining supplies she needed. I delivered Maine and Rhode Island packages and gave the New York packet to Isabelle Roberts. I did this to save postage. I believe we may have to increase the price of New Auxiliaries or change what we put in the supply packets because when the supply of Descriptive Books is depleted, it is going to cost more than \$2.50 to get them printed. I have two estimates of places in R.I. and Sister Margaret Atkinson has an estimate from Philadelphia.

The cost of supplies we include in the packets at the present time is \$8.25. Postage for mailing these packets is between \$2.90 and \$3.58, depending on distance. Plus, you have the price of the Charter.

I found it necessary to order 25 membership badges and have on order 10 PAP badges. To Frances Murray, PNP, thank you for getting me Membership Applications and Supply Lists when my supply of these items was depleted or getting low. This was no expense to the National Organization.

I owe a great deal of thanks to Esther Peiper, PNP, for all her help and advice this year. My first few months were difficult, but I would write or call Esther and she would answer my questions right away. I certainly have appreciated her help. To Margaret Atkinson, National Secretary, it has been a pleasure to work with you this year. You have been very helpful to me in many ways. It is all appreciated. To Mary Scofield, National Patriotic Instructor, and Isabelle Roberts, National Chief of Staff, it has been nice working with you. My thanks to both of you for your fine performance of your work with me and I trust our friendship will continue.

Before I go further, I would like to thank Helen Loll, PDP, NJ, for the notes she sent to Jo An Wheeler with suggestions and Jo An left them in the Treasurer's Instruction Book. They, along with Esther's assistance, have been a lot of help to me.

To Florence, my National President, it has been a pleasure to be a part of your official family. I wish you a very happy and successful Encampment and when it is over, may you have many happy memories to recall.

To all Past National Presidents, thanks to all for any help you have given me this year.

To all National Officers, I have enjoyed sharing this year with you. To all Departments and Auxiliaries, thank you for your cooperation whenever I needed it, especially the information for the IRS.

I have tried my best to be efficient and faithful to my office and to prove worthy of the confidence you placed in me when you appointed me. I am looking forward to this coming year. I believe it will be easier after this past year of learning experiences. I have enjoyed my office very much.

Eileen Coombs, PNP Treasurer PRESIDENT FLORENCE: Thank you so much Eileen, for your wonderful report. I think I would be crossed-eyed trying to go over all of those figures. We have received word that the recipient of the Patriotic Instructor's Fund is here. Sister Guides and Color Guards, please retire to the anti-room and escort our guest to the Altar.

PATRIOTIC INSTRUCTOR MARY SCOFIELD: National President Florence and the members of our Auxiliary, I would like to present to you the Commander of the Grand Rapids Home for the Veterans, Patrick McConnaughey.

PRESIDENT FLORENCE: On behalf of the National Organization, Auxiliary to Sons of Union Veterans of the Civil War, I extend to you a hearty welcome. Sisters salute. Guides and Color Guards, please escort our guest to my station.

SISTER MARY SCOFIELD: I would like to present you with this check on behalf of the Auxiliary to the Sons of Union Veterans of the Civil War.

Commandant McConnaughey gave a brief talk about the history of the Michigan Veterans Home and thanked everyone again for the kind contribution of \$350. He elected to remain in our meeting for the rest of the afternoon. The following is a brief summary of his talk, which you will find interesting.

COMMANDER PATRICK McCONNAUGHEY, GRAND RAPIDS HOME FOR THE VETERANS: I thank you very much for this gift. I assure you that it will be well appreciated and put to good use. I encourage all of you, if you are ever in the Grand Rapids area to visit with us. We keep our doors open and a friendly atmosphere. We would hope that you will stop by sometime. Thank you on behalf of the veterans that live at the home. We appreciate it very much. I brought some notes on the history of the home. The home has a very direct bearing on your organization. The home was originally the Michigan Veterans Home, which grew out of the Civil War and has quite a colorful past. A report about the home was commissioned about 4 years ago by the State of Michigan. After the Civil War in 1865, the first Veterans Home was commissioned in the Washington, D.C. area, or Old Soldiers Home. It was sponsored as a payroll deduction, funded out of each serviceman's pay; about 12.5 cents per veteran went into a fund for the National Home. By 1885, there were homes in a number of different states including Maine, Virginia, Wisconsin, Ohio, and Kansas. One of the primary thrusts of the National Home for Veterans was to house the disabled and growing aging veterans. Of the almost 700,000 population of Michigan, 93,000 enlisted for the War of the Rebellion. In August of 1883, the Soldiers and Sailors Association of S.W. Michigan passed a resolution urging Congress to establish a Michigan Home. Col. Sam Wells, President of the Association, appointed a committee to meet with the Grand Army of the Republic at its annual meeting in Detroit in January 1884. That is when a resolution was established and presented to Congress. It was finally approved in 1885 via a bill introduced in Michigan legislation, rather than Nationally.

A bounty bill was also proposed at this time giving every soldier who served in the Civil War a lump sum payment of \$100, to recognize the services and sacrifices. But it was vetoed because it was too expensive. General Logan assisted in passing Act 152 of 1885, signed in the State of Michigan, approving a GAR Veterans Home. But General Logan, founder of the GAR, died in 1886, right after it was finally approved.

The cemetery adjoining the Michigan home is shaped like a maltese cross. "This institution is built not as charity, but as fulfillment of a sacred trust as making good a solemn promise of the payment of an honest debt". The first Civil War veteran admitted was John Wright, 14th Michigan Infantry, in 1885. It was not officially dedicated as a home until 1886; 50,000 people attended the dedication including representatives from all of the GAR posts across the country. "... It was quite a day... The Star Spangled Banner was sung by Laura Wells; Michigan My Michigan, Marching Through Georgia, Camping on the Old Camp Grounds, When This Cruel War Is Over... were among the key songs the old veterans sang... a lunch of cold meat bread, cakes, hot coffee and tea was prepared... New Years Day 1887 was a most special day when all the Civil War veterans were finally moved into the home... and a celebration thereafter took place to commemorate this event..."

P.N.P. DORRIS SCHLENKER. Mr. McConnaughey, on behalf of the Organization, we thank you sincerely for taking the time from your busy schedule today to come forward to receive this token check. It is our custom in the city that we hold our National Encampment to leave a gift in memory of the GAR, to a veterans hospital or such charitable organization, as the selection by the Patriotic Instructor who has worked very hard this past year in fundraising. We want to thank you so much for the brief history you have given us about the home. I am from the Washington, D.C. area and I am very well aware of the Soldiers Home there and also General Logan's address. We thank you and all of your staff and the people who are continuing where the GAR left off in providing for these veterans. They have done so much for us. We are very proud of the GAR. Again, we thank you very much on behalf of the Organization and our National President for coming here today. I hope in some way our little gift will be of service in your organization in continuing the good work.

PRESIDENT FLORENCE: I just want to remind you that if you are interested in any supplies from our Treasurer, see Eileen after the meeting. I have also been informed that the Saturday night Open House is now scheduled for the Lake Michigan Room on the 5th Floor. Please note this change. Since we want to recess by 4 p.m., I think we will end the reports for today. I would like to ask Secretary Margaret Atkinson if she will read a few letters of correspondence before we adjourn.

NATIONAL SECRETARY MARGARET ATKINSON read several letters to the members.

- ... A note of thanks from the Chairlady on the Committee on Legislation, Ellinore Johnson, PNP, as Chair Emeritus.
- ... A thank you letter from Denise Spring, scholarship recipient.
- . . . Response from the Cathedral of the Pines for our kind contribution and thanks from David Faulkner, Executive Director.
- ... Acknowledgement from the Maine Veterans Home, Lori Borberg, Administrator, thanking the Auxiliary for \$350 last year and letting us know the gift will be put towards a wheelchair scale for the Home.

PRESIDENT FLORENCE: Thank you Sister Margaret. We said that we would like to be finished by 4 p.m. so that we can have a chance to relax and get ready for the banquet tonight. We will convene now. Please try to be here on time tomorrow so that we can get started promptly to finish the rest of our business. We have a lot of business reports to get through. Are there any other announcements to make, club meetings? Sister Eileen will stay until 4:30 p.m., if anyone wants to buy supplies. Please don't forget that the Chief of Staff's rehearsal will be at 4:15 p.m.

DORRIS SCHLENKER, PNP, MD-DE: Sister National President, I would like to announce that the Past National Presidents and Commander-in-Chiefs dinner will be held at 6 p.m. in the Imperial Room.

PDP MARGUERITE PLANTE, RI: I would like to announce that Fran's Fans Club will have a luncheon tomorrow.

PNP ANN WILLEKE, CT: The Nutmeggers will meet tomorrow in my room after lunch.

CHIEF OF STAFF ISABELLE ROBERTS: I would like to remind all the aides to remain in this room after this session because we will go over our opening for tomorrow. It will only take 15 minutes.

PRESIDENT FLORENCE: Sister Chaplain, please attend the Altar.

The Second Session ended at approximately 4 p.m. with the closing of the Bible by National Chaplain Hazel Masse.

# JOINT OPENING Joint Opening of the Sons of Union Veterans of the Civil War and Auxiliary Lansing, Michigan Friday, August 12, 1994

At approximately 9:20 a.m., the Joint Opening of the Sons of Union Veterans of the Civil War and Auxiliary opened. Isabelle Roberts, National Chief of Staff, presided as host with Norman Furman, Sons National Chief of Staff.

All the National Aides marched into the room with red, white, and blue streamers, lining up two by two, and making an Arch of Patriotic Colors, ending in the center of the room.

NATIONAL CHIEF OF STAFF ISABELLE ROBERTS: Brothers and Sisters, this is a great time at our convention, when our Brothers and our Sisters join together in the National Opening for our Convention.

SONS CHIEF OF STAFF NORMAN FURMAN: We will receive our Commander in Chief Allen W. Moore, escorted by his personal aide.

NATIONAL CHIEF OF STAFF ISABELLE ROBERTS: We will now receive our National President, Florence Spring, escorted by her mother, Elizabeth Sharp.

Guides and Color Guards escorted in Commander-in-Chief Allen W. Moore and National Auxiliary President Florence Spring, seating them in front of the podium.

The National Auxiliary and Sons Officers were escorted through the Arch of Patriotic Colors, introduced and then seated. The National Aides then reentered the room and were seated.

CHIEF OF STAFF NORMAN: Commander-in-Chief, I would like to congratulate you in having an excellent year. A lot of people wonder how you did it. I think I know. Do you all want to be let in on the secret? He used his name as a slogan. Moore. Moore new camps. Moore new members. Moore of everything. To keep in tradition, I will sing an outgoing song relieving you of your strenuous duties. You may have heard it before.

COMMANDER IN CHIEF ALLEN MOORE: Thank you very much Norman.

CHIEF OF STAFF ISABELLE ROBERTS: At this time, I would like to thank all those people who filled in, those people who helped me with decorations and everything else to make this a wonderful day. This program is not a one-person operation. It takes everybody to do it, and do it right. Even with the goofs. I didn't see any of the rest of you who helped make any goofs. It was just Norman, and he should know better, he's older than I am. I have only done it once before, he has done it several times. Once in a while I do make mistakes. Anybody that doesn't make a mistake is the one who doesn't do anything. If there is nothing else to mention, I think we will excuse the Sons so that they may go to their meeting. I will excuse the Auxiliary so that they can go to their room to continue their meeting. Thank you everyone.

We have one blessing this year--our National Treasurer has secured a free checking account, with a no-limit balance. If anyone of you have any ideas on how to raise some revenue from our membership Auxiliaries or Departments, please let me hear from you. I am a firm believer in being self-supporting. I'd just love to see the Encampment pay for itself. Expenses for the year come from Per Capita Tax. The Patriotic Instructor Funds are to be used or saved only for patriotic projects. One could say, "I have a Dream".

#### WASHINGTON D.C. REPRESENTATIVE REPORT

To be allowed to render continued service to our Order as we are admonished so to do in our installation ritual is an honor and a privilege I've had for 13 years.

Serving at the seat of our National Government offers many opportunities for participating in meetings and programs of a ceremonial or patriotic nature with people from other similar organizations, some who are not familiar with our Order, but soon hear of its origin and aims.

Positions of leadership and influence on your behalf are held in Civil War oriented organizations. The National Auxiliary was represented at all major ceremonies and commemoratives in Washington during the year. Liaison continues with the Sons, Daughters of Union Veterans, and the Military Order of the Loyal Legion.

On many occasions when invited as a guest to other Hereditary Womens' Organizations programs, it is noticeably apparent the public honor and respectful courtesy bestowed upon their National President, something that I think has fallen into disuse in our Order. The Office of National President is one of great honor, deserving of respectful courtesy, and in the past this courtesy was extended to her in many ways. I, therefore, make the following recommendation:

As soon as they return, we will do our election of officers so that we are finished before the Sons get here. If you would like to make your visitations now, please do so.

At approximately 1:35 p.m. our Greeting Committees went to respective meeting rooms.

SECRETARY MARGARET ATKINSON: I will continue reading more correspondence until they return.

- . . . A letter from Elsa Gibbons expressing thanks for keeping in touch with her. She is having much difficulty with her eyesight and wanted everyone to know that she will be thinking of us all.
- . . . Lorraine Orton, New York Woman's Relief Corp writing about the last widow of a Civil War veteran, Daisy Anderson of Mississippi and the fact that they presented her family with a badge.
- . . . An invitation to join the Blue Coats in a Gray City's co-sponsored Sons & Sons of Confederacy event, the 130th Anniversary Reenactment on April 1-2, 1995, Richmond, VA, commemorating the advance of Union forces into Richmond in 1865. ## NATIONAL HISTORIAN REPORT

## Preserve Our History

As National Historian, I am still receiving requests for information from people who are tracing their ancestors who they believe, by obituaries and family information, that their ancestor belonged to the Auxiliary or Sons of Union Veterans. By the records I have already compiled from the old Proceedings and State and disbanded Auxiliaries, at least three people joined as new members of the Sons of Union Veterans by the information I was able to give them. I also receive phone calls asking for information about our Organization.

I am still compiling records for easy accessibility in research. I appreciate all that is saved and given to me for the historical project. Thank you all for helping me Preserve our History. Being Historian is taking a lot of hours of recording, compiling and letter writing, but I enjoy the office very much.

I have answered 36 letters this year asking for information about the GAR Memorial Scholarship and 28 additional phone calls for information. I tell them the requirement is that they have a Civil War veterans ancestor. I always send them an application form and information of our Organization when I answer.

I am proud to now be able to send them our newly printed brochure. I had the privilege to work on the committee to compile these grand looking leaflets of information of our Organization.

At this time, I wish to present the following recommendations:

Recommendation: WHEREAS, the Auxiliaries do not know these brochures are now available, I recommend that each Auxiliary and each Department Secretary be sent 25 of these new brochures.

Recommendation: WHEREAS these brochures are of patriotic work, I recommend that the cost of these brochures and the postage of sending them to each Secretary be taken from the Patriotic Instructors Fund.

In the History of the changing of the name of the Auxiliary to Sons of Union Veterans from Sons of Veterans Auxiliary, that was voted to be changed at Grand Rapids, Michigan on September 3, 1925 at the 39th National Encampment. During 1927-1928, the National President was Mrs. Margaret L. Waters of Massachusetts, and the National Secretary was Flora Staples Whitney of Massachusetts. They re-issued nearly 600 new Charters during that time.

It has been truly a privilege serving with you this year. I couldn't have had anyone more congenial and more lovely to serve with. I see a lot of smiles here. I wish you much success in your future endeavors, and your work in this beloved Organization.

National President Florence reminded all newly elected officers to please leave their names, addresses and telephone numbers with National Secretary Margaret Atkinson before they leave today. At approximately 3:00 p.m., the meeting resumed with the reading of REPORTS FROM COMMITTEES.

## **Special Appointed Committees**

#### REPORT OF COMMITTEE ON MEMBERSHIP BROCHURE

It was voted at the last convention to have a committee come up with an informational brochure outlining our past and present history, activities, goals and eligibility. I appointed Bea Greenwalt, Margaret Atkinson and myself to the committee.

Margaret and Bea drafted up a brochure and I could not get my mind into it. Drafts went back and forth and one morning in February, when I was in the office at 6 a.m., I told myself I had to get with it. I drafted off my suggestions to go along with theirs. When we all were pretty well set on what we agreed to do, I attempted to put it on my computer. So much for the brochure being on 8 1/2 x 11 paper. Ours went four columns on two sides and no room for the title page. I reduced the print and we made it on the legal paper. However, my computer then broke and I could not figure how to print the brochure. When my computer was returned, the repairman kindly got everything straightened out and the brochure came out right.

Bea wanted to have the badge in color on the title page and Margaret and I thought that it was a good idea. I believe it adds a lot to the brochure. We originally ordered 500 for \$100 but the printer had to buy a ream of 1000 and he said he would run another 500 for \$5.00 more or a total of \$115 for 1000, or .115 a brochure. I don't think you can beat that price and this is a brochure that will catch the peoples eye.

We do not feel that 1000 of these are enough. The Committee makes this recommendation:

Recommendation #1: That we order 2000 more brochures from the printer and he has quoted us a price of \$150.00.

Recommendation #2: The Committee also worked on updating the application as recommended by Historian Bea Greenwalt last year. We ask your approval that we get them printed on bond paper.

National President Florence brought these recommendations to the floor for discussion and vote.

Much discussion about the brochure and how and who was going to pay for the additional printing of it ensued, as well as discussion about the need to have such a brochure available to prospective members, or people who expressed an interest in the organization, but did not know what the organization was all about. A few members did not want to spend the extra money to have the new brochure printed up. This brochure is an extremely important tool in helping to educate the public about the Auxiliary.

A motion was finally made by Sister Sarah Cherry to approve the recommendation of the Membership Brochure Committee to have an additional 2000 brochures printed. It was seconded by PNP Martha Johnson, PA and several others.

Discussion also took place about the new Membership Application, and if it should be printed on more attractive bond paper.

A motion was made by PNP Dorris Schlenker, MD-DE to approve the printing of the new Membership Application Forms on fine quality paper. It was seconded by Sister Sarah Cherry.

## PROVISIONAL CHARTER DESIGN

To be appointed to this special committee taught me a lesson, don't make a recommendation for a special project unless you're prepared to serve.

I still think the idea of a smaller certificate for Provisional Auxiliaries was a good one. With this in mind, I came up with the idea of using our regular charter, shrinking it, inserting the word "Provisional" where needed, making space for signature of Instituting Officer and being sure that this charter could be used where there was a Department and also if there was no Department. It had to be an all-purpose Provisional Charter.

Having a rough draft ready, I called my son for his assistance in putting it all together and printing some samples.

These were then sent to the National President and the two other members of this committee for their approval or any changes they thought should be made. All three wrote me with their approval, so then a call was made again to my son to roll the presses on a good quality parchment. This is the result, and 300 copies were given to our National Secretary.

There will be no expense to the National Auxiliary for these Charters. It was my plan to assume all costs, but my son did not wish to take any money from me. So these new Provisional Charters are donated with love from Daniel Schlenker in memory of his great-great-grandfather, Daniel B. Schlenker, a Civil War Veteran and member of the G.A.R.

National President Florence thanked Sister Dorris and her committee and especially her son for helping to print up the new Provisional Charters.

We have not had any meetings as yet with the Sons regarding the 1995 Encampment which will be held in Columbus, Ohio. Margaret Atkinson has gone out to see the hotel and reports it is very nice. I have heard rumors that it will be held in New York in 1996. But I also understand that Missouri expressed an interest in hosting the 1996 Encampment. I am hopeful that we will have a Site Committee meeting with the Sons this weekend and will talk to Charles Corfman. I will be back in touch if we do meet. I just want to relay to you that the Daughters are scheduled to hold their 1999 National Encampment in Maine at the Ramada Inn. I talked with Gail Butterfield who is the President of the Daughters this year and it is going to be interesting. I just wanted to pass this information on since Bea reported on the 1999 Encampment of the Union and Confederates.

# FIFTH SESSION Saturday Morning, August 13, 1994 - 9:35 a.m.

## National Chaplain Hazel Masse opened the Bible.

PRESIDENT FLORENCE: I would like to thank Sister Isabelle and all the members for the Courtesy Hour last night. I really, really enjoyed it and I had so much fun. This is one of the reasons why I was very adamant about the Sons not stopping the Courtesy Hour. I feel that we all need that break. #### LEGISLATIVE COMMITTEE REPORT

I remember the Grand Army men and heard several say, "We went to Washington and told the President what we thought."

## **RECOMMENDATIONS FOR 1994-95**

These recommendations actually came from Ellinore Johnson.

Recommendation #1: That we urge Congress to pass S1033 to preserve the Shenandoah Valley Battlefield Partnership Act.

Last July the Civil War Sites Advisory Commission made its report. It found that about 18% of the known Civil War battlefields still in good or fair condition are threatened by development by the year 2005, little more than 10 years away. The Commission recommended the passage of the Civil War Preservation Act and the spending of some \$70 million to help states and nonprofit organizations through matching grants purchase land at 50 of the most significant and vulnerable sites. The Commission would also like to see the Resolution Trust Corporation turn over lands that it has obtained from failed savings and loans where those parcels are adjacent to battlefield sites. Examples are more than 300 acres near the Battle of Wilderness in Virginia and over 400 acres near the Richmond National Battlefield Park.

PRESIDENT FLORENCE: Let us vote on this first recommendation. That we urge Congress to pass S1033 to preserve the Shenandoah Valley Battlefield Park Partnership Act.

Moved by Sister Martha Johnson, PDP, PA, seconded by Sister Emma Prince, PDP, CT, and Mary Jo Long, DP, PA. Motion carried.

Recommendation #2: That we support the Civil War Sites Advisory Commission and urge the passage of the Civil War Heritage Preservation Act to preserve our battle sites and keep them from development. PRESIDENT FLORENCE: Let us vote on this recommendation. That we support the Civil War Sites Advisory Commission . Motion made by Martha Johnson, PDP, PA, seconded by Mary Jo Long, DP, PA. The National Secretary will also send a letter supporting this. Motion carried.

Recommendation #3: That we support HR4393, the Grants Tomb National Memorial Act of 1994.

Restoration of Grants Tomb. It has taken a college student, Frank Scaturro of Columbia University, to awaken the nation to the sad condition and plight of Grant's Tomb in New York City. After a suit was filed in federal court in April to compel the Federal Government to act, the National Park Service agreed to seek from Congress \$400,000 for the current fiscal year and \$450,000 for the following year to repair, refurbish, and revitalize the burial site of our 18th President and his wife. These amounts of money compare with only \$126,000 authorized for this past fiscal year and still fall far short of the need. In May of this year, Rep. Jerrold Nadler of New York introduced HR4393, the Grant's Tomb National Memorial Act of 1994. This measure calls for the restoration and preservation of the site as a national memorial and provides for the erection of a visitor's center and 24-hour honor guard among various other means to heighten the level of security.

PRESIDENT FLORENCE: You have heard the reading of this recommendation, what is your pleasure? Motion made by National Secretary Margaret that we send a letter in support and in the first General Orders, urge all individuals members to do the same, and seconded by Beatrice Greenwalt, PNP, NY. Motion carried.

Miscellaneous Matters. Senator Dale Bumpers of Arkansas has introduced Senate Joint Resolution 161 that designates April of 1994 as "Civil War History Month."

Representative Earl Hutto of Florida has introduced House Joint Resolution 361 that would designate 1995 as the "Year of the Flag."

Two measures that would return the Federal observance of Memorial Day to May 30, S119 and HR1169 have died in committee.

I'm going to mention a few laws that affect your pocketbooks, and, in some cases, the quality of your lives. Please watch the news and contact your representatives.

- 1. Your Social Security has been taxed for some time. PL103-66 was passed this year which raised the threshold for singles to \$34,000 and couples to \$44,000. Predictions are that this will be changed (lowered) in the
- 2. In connection with Social Security is the so called Social Security Notch Bill passed in 1977 which meant that persons born between 1917 and 1926 received lower benefits. This was necessary to save Social Security from bankruptcy at the time. Now a committee has been established to rectify this. If any of you are interested contact: Commission on Social Security "Notch" Issues, 10th Floor, East Tower, 1100 New York Avenue, NW, Washington, D.C. 20005 or call (202) 336-8730.
- The Base Closure Act of 1990 has run into snags. The closure of the Philadelphia Naval Shipyard has raised questions and may end up in the courts, including the Supreme Court. If you live in an area of base closure, watch procedures and act accordingly.

I had hoped to have the numbers of the Healthcare Bills, but Congress is still arguing. Please watch this subject which affects all of us. Clinton's bill would have killed all of us in more ways than one. Senator Mitchell of Maine and a group of Democrats have tried to modify it and hope to pass it. From what I have read, this is a disaster too. The GOP will come up with some plan and I understand there is a bipartisan plan coming up. They may all be wrong for you, so please watch and contact your Senator and Congressman at once. Sister Florence, we wish for you a successful and harmoniousencampment.

NATIONAL PRESIDENT FLORENCE: A motion has been made by Anne O. Clayton, PNP, NJ to accept the report and spread it in full in the minutes and the Committee be discharged with thanks. It is seconded by Mary Jo Long, PA. Now we will hear the Report of the Committee on Constitution Rules and Regulations, Sister Viola

## **CONSTITUTION, RULES & REGULATIONS COMMITTEE REPORT**

We, your Committee on the Constitution Rules and Regulations, have met and received the Recommendations presented to us affecting our CR&R.

Recommendation #1: After Section #2, page 24, at the end of paragraph add: When a member is given a Life Membership, she must pay her dues for one (1) year after her Life Membership. If a Life Membership is purchased between January 1 and June 30, the first year's interest will be one half the amount. After that first year the accrued interest will be mailed January 1, to the Life Members Auxiliary as her dues payment for that year. This has been approved by the Committee.

A motion was made by Sister Emma Prince, PDP, CT, to accept this recommendation and seconded by Sister Esther Peiper, PNP, OH.

It comes to my attention that the Per Capita Tax is not paid to National on Life Members for the Sons. The Auxiliary doesn't have that in their CR&R.

Please note that a discussion took place on this issue. Sister Esther Peiper clarified that National pays after the first year of purchase of a Life Membership, \$6.00 to the Auxiliary Treasurer for the dues of the Life Member. Then \$1.40 must be paid to National. Sister Florence Jansson, PNP, NJ, indicated that the Auxiliary, after receiving \$6.00 for membership, would have to pay the per capita to the Department. In the Sons, it does not mention anything about the camps, in the CR&R that the Department does not send to National the per capita. It was suggested to Viola that it be brought to the membership whether the Auxiliary wants to work it the same way, or whether they should send the per capita to National. Sister Esther Peiper, commented that in our CR&R that the Auxiliary must pay per capita tax to the Department. Sister Florence Jansson said that we don't have to follow the Sons measures. Sister Eileen Coombs, National Treasurer, commented that if you pay Life Memberships in the last half of the year, you do not get that interest on January 1 the following year. Any sisters that became Life Members in November, for example, had to pay dues to their Auxiliary for 1994-come January 1, 1995, I will be sending \$6.00 to their Auxiliary Treasurer. All the treasurers of auxiliaries who have life members have been paying per capita tax to their department. The Department has been paying per capita tax through National. Bear in mind, if you are going to cut down on per capita taxes, we are still underestimating our per capita tax. Sister Florence indicated that the Committee was looking for approval to have the Department send the per capita to National and put this in our CR&R. If it is decided not to do so, then nothing is to be done. National President Florence reads the CR&R: Under Finances, Article 7, Section 2, "The per capita tax from each department to National shall be 35 cents per quarter on each member." Sister Dawn Hayner comments that we should leave it as it is.

Sister Frances Murray, PNP, ME, moved that we accept the motion to leave it as is, but include the phrase "including Life Members" be added to our CR&R where we describe that the per capita taxes are paid; seconded by Sister Margaret Atkinson, NS, PA.

At the Pennsylvania Department Encampment in Kittanning in June 1994, the subject of dual membership was brought up before the members. Hearing this, National President Florence Spring so stated this was not in accord with the CR&R Regulations, and would have to be put before National as a recommendation. Recommendation #2: That dual membership be permitted for members. On behalf of the Pennsylvania members, and upon those present, we are asking this to be brought up for discussion at National for approval. A motion was made by Linda Barnhart, PDP, and seconded by several that as secretary, I forward this to National. Thank you for your consideration.

Martha Johnson, Secretary Department of Pennsylvania

Discussion took place regarding dual memberships. Sister Betty Baker, NY, thought there was no point in having dual memberships. Sister Esther Peiper indicated that she knows that dual membership exists, especially between some of the smaller auxiliaries, but it is not actually approved by National. National needs a direct total membership. Some of the smaller auxiliaries do need the extra membership support. You can only be counted once as far as I am concerned, and it is not really addressed in our CR&R. We should leave it up to the departments to handle on their own. I belong to the Department of Pennsylvania and also pay dues, but I also wish to attend the auxiliary in the state I live now and support it as well by paying dues. I think that National should have nothing to do with it, and let each department handle it instead and the departments are told that they cannot pay per capita tax on a person with the dual membership. My dues are a gift to the

auxiliary, but they do not count me as an official member since I prefer to belong to Pennsylvania. Sister Eileen Coombs indicated that although she belongs to the Department of Maine and pays her dues there, she does reside in Rhode Island and that the Department of Rhode Island accepts her visitations any time. She thanks the RI auxiliary for having her be a part of their meetings since she cannot travel up to Maine that often. She does not pay dues to RI, but indicated that she supports many of their functions. Bea Greenwalt stated that she still belongs to the NY Department and pays her dues, but she attends the Ohio meetings since she resides in Ohio, but supports Ohio by participating in their programs; she does not pay membership in Ohio. She did note that you cannot be an elected officer in the dual membership auxiliary. Sister National Secretary Margaret Atkinson knows that many of her Pennsylvania department members have dual membership in other auxiliaries, and also knows that the Sons have dual membership. National President Florence Spring noted that she realizes that dual membership exists, but somehow feels it may cause an awful lot of confusion to belong to two departments, and if you are paying two dues, which department pays that person's per capita tax. If both departments send them in not realizing it, then they are paying for one person twice, and counting them twice. Sister Margaret Atkinson stated that they can go to both departments encampments and vote, but at National, they must only register under one department. Sister Frances Murray stated that this would not be legal, and any change in the CR&R must be made public and announced in the General Orders so many days before National Convention. Sister Mary Mierka, DP, RI, commented that the Sons do allow dual memberships and that she considers dual memberships as a way of supporting other departments, and they could also use the membership dues. She is originally from Michigan and would like the option of supporting her home state for example, or any other state. The Sons do not count you as double. Their system is set up with codes and a dual member is counted only once, but considered a member in both camps. The CR&R Committee did not take any action on this issue, and felt that it should be brought up on the floor for further discussion and vote. Sister Dawn Hayner, MD/DE, indicated that this is a department-level decision and has nothing to do with National, as long as dues are being paid, and the per capita tax is paid to National appropriately. She suggested that this issue be brought up in the next General Orders and sent out to the members. Sister Beatrice Greenwalt stated that National does not accept dual memberships at any level, if you want to support another auxiliary by giving \$100 then that's your choice, but to have dual membership, I see no point in this.

Beatrice Greenwalt, PNP, finally made the motion that National not accept dual memberships. It was seconded by several and so carried.

This completes our report Sister National President. We trust our efforts have proved satisfactory. It has been our pleasure to serve the National Organization.

Florence Jansson, PNP-NJ: I have tried ever since I was National President in 1970 to obtain a copy of the Sons CR&R and I have asked several now Past Commanders for years if I could have one. I was never able to get one. Fortunately, when I was appointed to the CR&R Committee, I finally wrote to Dick Schlenker, PC in C, and he sent me their book although it is quite old but we find it useful. I was very grateful to him.

PRESIDENT FLORENCE: Now we will continue with the report from the Rituals Committee.

#### RITUALS COMMITTEE

(Read by National Secretary Margaret Atkinson)

As Chairman of the Ritual Committee, I want to report that as up to this time, I have not received any communications about any changes in the Ritual. I wish for our National President a wonderful Encampment, and to our incoming officers, I pledge my loyal support. Thank you for my appointment to this committee.

To the Members of Council Frances Murray, Alyce Ponticelli, and Dawn Hayner, who have audited the books of the National Secretary and National Treasurer and performed well all the duties expected of them, we extend to you our sincere thanks.

## Recommendations: None.

To National Secretary Margaret Atkinson, having fulfilled two years of office when we desperately needed someone, we thank you most whole heartedly for your expertise and devotion to a monumental job. We hope for you a year of excitement, love and joy.
